Membership Advantages

Q. How do I qualify for membership?

- A. If you are actively engaged in farming AND do business with Ag Partners, you are eligible to become a member. There are two primary advantages—each member receives a voting privilege and receives patronage, or dividends, for doing business with Ag Partners. Voting members elect their Alceco board members for a three-year term.

Q. How do I apply for membership?

- A. Simply complete this membership application. The majority of the member dividend is paid in cash while a portion is applied to an equity share. All business with Ag Partners is eligible for patronage if your application is received by fiscal year end.

This application for membership may be rejected for any reason satisfactory to the Board of Directors, including but not limited to, violations of contracts, credit policies and other policies of this association. Upon acceptance by the Board of Directors of this application, the same shall be fully effective without further notice to the applicant.
